<b>TYPE OF DATA PROCESSED:</b>	The data processed by the Data Controller, collected directly from the data subject, are those necessary to achieve the purposes set out in the following point. <b>SOURCE OF PERSONAL DATA:</b>	The personal data in the possession of the <b>Data Controller</b> is collected directly from the person concerned when filling in this form.
<b>PURPOSE OF DATA PROCESSING AND LEGAL BASIS:</b>	The processing of your data, collected and stored in connection with the completion of this form, has as its legal basis your consent and is carried out for the following purposes: <ul style="list-style-type: none"> <li>• Responding to requests for information about our services.</li> </ul>

<b>RETENTION PERIOD:</b>	The data collected will be stored until you revoke your consent or for a period of approximately 60 months.
